**December 19** Last day to post Notice of Deadline to File Applications for Place on

the Ballot -- Katy Education Support Complex bulletin board.

January 17 Semiannual campaign financial report due for all

candidates and/or officeholders who have a campaign treasurer on file (even if there is no activity to report)

(Form C/OH or C/OH-UC).

**January 18** First day for a candidate to apply for a place on the ballot.

**February 17** Deadline to order May, 2017 election.

5:00 p.m. -Deadline to file application for a place on the ballot.

Form CTA (Appointment of a Campaign Treasurer) must be filed by candidates before any contributions or expenses may be

incurred.

**February 24** 5:00 p.m. -Deadline for candidates to withdraw from the 2017

election.

**February 27** 5:00p.m.-Drawing for place on the ballot-KISD Education Support

Complex lobby.

March 7 Early voting clerk may begin mailing early voting ballots to

applicants as soon as ballots are available.

**April 6** All opposed candidates must file a report of contributions

and expenditures by 5:00p.m. (30 days prior to the election)

(Form C/OH)

April 6	Last day to register to vote in the May 6, 2017 election.
April 17	Last day to post notices of election on bulletin boards.
April 19	Last day to publish notice of the public Logic and Accuracy (L & A) Test of early voting and election day automatic tabulating equipment.
April 21	Last day to conduct public Language and Accuracy Test of automatic tabulating equipment for use during the early voting period.
April 24	Begin early voting by personal appearance.
April 25	Last day to receive applications for early voting ballots to be voted by mail.
April 26	Last day of period during which notice of election must be published.
April 28	All opposed candidates must file a report of contributions and expenditures by 5:00 p.m. (8 days prior to the election) (Form C/OH)
April 29	Special Early Voting (Saturday, 7:00a.m 6:00p.m.)
May 2	Last day to vote early by personal appearance.
May 6	ELECTION DAY - 7:00a.m7:00p.mPolls are open.
May 8	Delivery of provisional voter verification for review.
May 9	First possible day to conduct official local canvass of returns if provisional ballots have been verified and counted and no overseas ballots are outstanding.
May 15	Last day for early voting ballot board to convene and count any late ballots that were submitted from outside the United States and received by Thursday, May 11, 2017. Recommended last day for early voting ballot board to convene to qualify and count any provisional ballots that have been reviewed by the voter registrar.
May 15-17	Board of Trustees  meets  to  can vass  election  returns.
June 5	Last day to file electronic precinct-by-precinct returns with Secretary of State.

June 9

Final financial report of campaign contributions and/or expenses due by 5:00p.m. (Form C/OH-FR) if a filer expects to accept no further political contributions and to make no further political expenditures and the filer expects to take no further action to get elected to a public office. Filing a Final Report terminates a filer's campaign treasurer appointment and relieves filer from any additional filing obligations as a candidate.

July 6

First day that ballot box(es) may be unlocked and its voted ballots transferred to another secure container for the remainder of the preservation period.

July 17

Semiannual campaign financial report due for all candidates and/or officeholders who have a campaign treasurer on file (even if there is no activity to report) (Form C/OH). Unless the final report (form C/OH-FR) is filed, the candidate must submit Form C/OH by July 17 and January 17 of each year.
