THE FACTS:

- ✓ Home APPRAISAL VALUES are set by the COUNTY APPRAISAL DISTRICT
- ✓ When APPRAISAL VALUES INCREASE, we PAY MORE IN TAXES
- ✓ The STATE receives the additional tax revenue, NOT the school district

Important to know...

- ✓ SCHOOL TAX RATE is set by the school district
- ✓ The state is DECREASING our SCHOOL TAX RATE, with or without a schools bond
- ✓ Seniors 65+ are exempt from any increase in school taxes on their homestead
