JUNIORS:

You will *NOT* go to Miller Career Center in the morning of Thursday October 12th. You must report to CRHS by 7:15 am for the PSAT.

Juniors who attend Miller in the afternoon: The Miller bus will leave at 12:35 pm on Thursday, after testing and lunch. Miller knows our schedule and is expecting that.

SENIORS:

You will keep your regular Miller schedule in the morning and go to Miller for 1st – 3rd period. You will be dismissed at 9:30 am. Seniors returning to CRHS will follow the adjusted bell schedule above.

IMPORTANT INFO

No one will be excused from testing rooms until ALL campus testing has been completed.

- Please do not schedule conflicting appointments.

We will follow an alternate bell schedule and go to lunch from your testing room/study hall.

MILLER STUDENTS:

- Juniors will NOT go to Miller Career Center on the morning of October 12th and must report to CRHS test rooms by 7:15 a.m.
- October 12th- Juniors who go to Miller Career Center in the afternoon will follow an adjusted bus schedule after testing and lunch are complete. Please see schedule.
- Seniors with MCTC in the AM – Report to MCTC as usual.
- Seniors with MCTC in the PM – You will attend in the afternoon as usual.

CREATING A COLLEGE BOARD ACCOUNT

- It is a good idea for every 10th and 11th grade student to create a College Board account using a non-school email address.
- This is where you will be able to check your scores.

WHAT STUDENTS NEED TO BRING ON TEST DAY:

- Valid Photo ID (school ID / driver's license)–You'll be checked!
- Email address (personal email, **NOT school email**)
- A bag/backpack to hold your belongings during testing
- Do NOT bring: Wearable technology, pens, **HIGHLIGHTERS**, mechanical/colored pencils, books, dictionaries, etc.

Snacks – College Board does **NOT** allow snacks/drinks to be consumed **during** testing. All snacks/drinks must be consumed away from the test during scheduled breaks only.

EXPECTATIONS:

USING PROHIBITED AIDS WILL RESULT IN YOUR TEST NOT BEING SCORED








- Cell phones / smartwatches (all electronics) will be turned off and placed in backpacks during testing
- Students may NOT use mechanical pencils or highlighters
- Students may NOT have books or papers of any kind at their desks during testing.

Permitted and Prohibited Items

Unless a student has a College Board-approved accommodation for the item:




Items Allowed on Student's Desks

(These are the only items allowed on student's desks)

-  Fully charged testing device
-  Sign-in ticket
-  Calculator (if desired, the testing app has an embedded calculator)
-  External mouse and pad (if desired)
-  External keyboard for tablets only
-  Scratch paper provided by the proctor
-  Pencil or pen for making notes












Permitted Items During Testing

(These are stored under the student's desk or in a backpack)

-  Charging cord or power bank
-  Snacks/drinks
-  Hand sanitizer and cleaning supplies

Prohibited Items

(Students cannot access these items during the test or breaks)

-  Mobile phone, smartwatch, or electronic devices other than testing device
-  Watches that beep, make a noise, or have an alarm
-  External keyboard, if using a laptop
-  Stylus, secondary battery
-  Separate computer monitor
-  Privacy screen not permanently fixed to device
-  Books, notebooks, keyboard maps, or references of any kind
-  Scratch paper not provided by the proctor
-  Sticky notes/papers with login/password info must be collected before start code is entered
-  Headphones, earbuds, or earplugs
-  Any camera or recording device
-  Separate timer
-  Another testing device
-  Weapons or firearms

CALCULATORS

- CRHS will provide a calculator for each student testing.
- ALL scientific calculators are allowed, even if you do not see them on the list
- Graphing calculators must be on the Acceptable Calculator list (and will be checked)

Acceptable Calculators

The following calculators are acceptable for use on the Math Test – Calculator. Only this test permits the use of a calculator (unless a student has an approved accommodation). This list doesn't include every calculator model. Call PSAT/NMSQT Support if you aren't sure about a calculator that's not on this list.

- All scientific calculators, which can perform complex mathematical functions but don't have a graphing feature, are acceptable as long as they don't have any prohibited features given under Unacceptable Calculators.
- All 4-function calculators are acceptable but not recommended.
- Graphing calculators included in the following table are acceptable.

Unacceptable Calculators

Students are not allowed to use any of the following calculators, unless specifically approved by College Board as an accommodation:

- Laptops or other computers, tablets, mobile phones, smartwatches, or wearable technology
- Models that can access the internet or have wireless, Bluetooth, cellular, audio/video recording and playing, camera, or any other smartphone-type features
- Models that have a computer-style (QWERTY) keyboard, pen input, or stylus

- Models that use electrical outlets, make noise, or have a paper tape

In addition, the use of hardware peripherals such as a stylus with an approved calculator isn't permitted. Some models with touchscreen capability are not permitted (e.g., Casio ClassPad). Check the list of acceptable graphing calculators above for models that are permitted.
