# Parent and Family Engagement (PFE) Policy

# **Statement of Purpose**

T. H. McDonald Junior High believes that all students should have every available opportunity for reaching their highest potential. MDJH is committed to providing all students with a positive and safe environment to promote learning, growth and success. The focus of the campus includes ensuring that all students continuously improve academic achievement in all content areas; student performance on STAAR meets or exceeds the state comparison campuses; and all students demonstrate at least one year of growth annually. Students experiencing difficulties in core content areas – Reading, Mathematics, Science, Social Studies – will receive intervention opportunities through differentiated classroom instruction; specialized Advisory; Reading Intervention and/or Math Intervention class; before/after school tutorials; access to Imagine Math (or Ascend), Freckle, Lexia; and/or special Saturday tutorials. The success of our students relies upon the collaborative efforts and support of our community.

A PFE policy is designed to promote parental involvement that supports our school's beliefs and has been established to ensure student excellence. An advisory team will meet annually to review, evaluate, and revise this policy to reinforce our campus goals.

Staff-parent/guardian communication will be addressed throughout the year. It is our goal to promote parent/guardian communication because we believe that student success is a shared responsibility. Ongoing, two-way communication will occur throughout the year in various ways. Parents/Guardians will be informed regularly about their child's academic performance and school curriculum through interim progress reports; report cards; parent/guardian conferences; telephone calls; emails; Panther Post; Katy ISD/campus websites; postcards and other written communication. Responsibilities of parents/guardians, students, and staff are outlined in the School-Parent Compact Agreement (posted on MDJH website under Title I), which is approved by stakeholders of MDJH and is designed to ensure student success in and beyond school.

An annual Title I meeting will be held each year at various times to orient parents/guardians to the year's proposed activities and to review the campus needs assessments. A description and evaluation of the PFE Policy will be shared. Feedback will be taken for continued program evaluation and revision.

The effectiveness of our programs and parent/guardian involvement will be evaluated throughout the year. Data will be collected to design strategies for more effective parent/guardian involvement. Revisions and methods to improve our practices will be reviewed and discussed.

Title I funds will be allocated towards student achievement. The Campus Advisory Team (CAT), parents/guardians, and MDJH staff will have input into the use of funds. Funds may be used for professional development; scholarships; instructional materials; program implementation; staff salaries; and parent/guardian involvement opportunities. The Katy ISD website provides parents/guardians with important information regarding the curriculum, grading policies, student code of conduct, local and state testing calendars,

academic opportunities, district-provided programs, and school performances. News related to our programs, as well as special meeting times, will be posted on the website, in the school newsletter (Panther Post), social media, posted flyers (website, newsletter and front office area).

## **Developing the Policy**

An advisory committee will be formed consisting of parents/guardians, community members, teachers, and administrators to develop and revise the Parent and Family Engagement Policy of MDJH. The parent/guardian volunteers will represent the diversity of the student population and one or more parents/guardians on the advisory committee will have children participating in the Title I program; a translator will be present. The committee will meet to write, revise, and publish a PFE policy that will encourage and support parent/guardian involvement at MDJH. The PFE Policy will continually be evaluated, updated, and revised to address the goals and needs of all stakeholders. The advisory committee will convene at a time and place convenient to all its members.

#### **Annual Meetings**

T. H. McDonald Junior High will conduct multiple annual Title I meetings at the beginning and throughout the school year for all parents/guardians as a form of orientation to the Title I program. At that meeting, the Title I program will be described, the PFE Policy will be distributed and opportunities for parent/guardian participation will be explained. Parent/Guardian volunteers will be recruited to serve on the Campus Advisory Team (CAT).

A minimum of two additional campus meetings will be held throughout the year. These meetings will provide parents/guardians the opportunity to learn about MDJH and to participate in their child's education. In April or May of each year, Katy Independent School District will hold a public Title I meeting to evaluate and share information about the Title I program. Parents/Guardians will be invited to this meeting by each campus and notice of this meeting will be distributed via social media, school newsletter (Panther Post), district and school websites.

Additionally, the evaluation of the Title I program will be conducted through a family questionnaire distributed at the end of each school year. These questionnaires will be reviewed at that time to determine suggested areas of improvement.

Parents/Guardians are encouraged to be involved in their child's education and are encouraged to offer suggestions as all stakeholders work together to ensure that all children succeed at MDJH.

# **Building Capacity**

T. H. McDonald Junior High values the partnership of the parents/guardians in their student's education. ### **Evaluation**

T. H. McDonald Junior High will work with the Campus Advisory Team (CAT) to evaluate the effectiveness of the parent/guardian involvement program. Surveys, family and staff questionnaires, assessment data, and other resources will be used to determine needs and develop revised strategies for student success. The Title I personnel will meet with other Title I colleagues across the district for suggestions on improving our program and parent/guardian involvement. ## **Funding**

Katy ISD is required to set aside at least 1% of its Title I funds for the purpose of parent/guardian involvement. Those funds will be divided among the Title I campuses. The campus principal will consult with the Campus Advisory Team regarding the allowable uses of the funds. The campus principal will then approve the use of the funds designated for parent/guardian involvement. T. H. McDonald Junior High will spend Title I funds according to identified, comprehensive needs and Title I guidelines and will document activities and expenditures.

Funds will be used for staff salaries, materials, supplies, classroom manipulatives, literacy resources, activities, parent/guardian involvement, parent/guardian and teacher trainings and other effective methods and instructional strategies that increase the quality of learning at T. H. McDonald Junior High.

This policy is distributed at all Title I meetings, posted on the campus website under Title I, available in the counseling office, Title I office and administrative offices.
